#### 13 WEEKS OF EXCLUSIVE USE

Each share entitles you to 13 weeks per year. A fair, rotating booking calendar ensures that every co-owner gets priority access during peak seasons over the course of a 4-year cycle.

#### **FULLY MANAGED EXPERIENCE**

Everything is taken care of: cleaning, maintenance, changeovers, and preparation. Just arrive, unwind, and enjoy.

Professional housekeeping ensures your home is always pristine.

### **SPLIT THE COSTS**

All running costs — including utilities, site fees, insurance, maintenance, and housekeeping — are shared equally between the co-owners. No surprises. No stress.

Utilities, insurance, site fees, cleaning, repairs, linen, broadband, and management - all included and divided equally between owners. Transparent budgets reviewed annually.

### WILL I MEET MY CO-OWNERS?

Only if you choose to.
